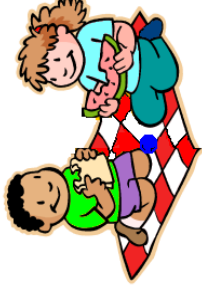

Summer Lunch Service Program
FREE MEALS for Children Ages 1-18**

Beginning June 6 and ending July 29, 2022, free nutritious meals will be provided to all children 1-18 years old who are present at the meal service locations. The meals served will be the same for all children regardless of race, color, national origin, sex, age or disability and there will be no discrimination in the course of the meal service.

Meals will be curbside pick-up, provided first-come, first-served at the following meal site location(s) and scheduled time(s):

All meal services will be for students only. Students MUST be present to receive a meal. For the protection from spreading illnesses families should observe appropriate social distancing. Meals may be eaten on or off site. In the case of heavy rain, mobile sites will be available at the schools for curbside pick-up or in the MESD marked Suburban to be taken home.
