





**CITY OF MORIARTY
SPECIAL CITY COUNCIL MEETING

TIME, PLACE & ATTENDANCE	The Moriarty City Council met in a special meeting on May 08, 2025, with the following members present: Mayor Webb, Councilors Steve Anaya, Bobby Ortiz, Jeremy Trujillo and Kim Garcia.
CALL TO ORDER	Mayor Brandon Webb called the meeting to order at 6:05 p.m.
ADD FOR DISCUSSION ONLY	Councilor Steve Anaya requested an update regarding the lack of water issues at Estancia. Mayor Webb stated Moriarty is listed as a back-up in Estancia's contingency plan confirming Moriarty will not deplete its water system and that the contingency plan would be presented to Council if brought forth.
APPROVAL OF AGENDA	Steve Anaya moved to approve the agenda. Kim Garcia Seconded. Steve Anaya, Bobby Ortiz, Kim Garcia and Jeremy Trujillo voted AYE. Motion Carried.
ITEMS FOR DISCUSSION/ACTION	
CITY CLERK OFFICE	UPDATE ABOUT CITY CLERK OFFICE STAFF RESPONSIBILITIES. City Clerk, Deborah Liu presented and clarified the job responsibilities of each City Clerk Office staff, and the added responsibilities each one carries while addressing the vacancy of a Marketing Communications Manager. No Action.
CITY CLERK OFFICE	INTRODUCTION AND PRESENTATION OF KAREN ALARID AND EMILY SANCHEZ REGARDING A PROSPECTED 90-DAY CONTRACTUAL AGREEMENT FOR ACCOUNTING ASSISTANCE SERVICES AT THE CITY CLERK'S OFFICE. Ms. Alarid and Ms. Sanchez introduced themselves and spoke about their request to be contracted to assist Moriarty with the finances. No Action.
CLOSED SESSION	Kim Garcia motioned to go into closed session pursuant to SS 10-15-1 H (6), in particular to discuss the compensation of a proposed 90-day contractual agreement between Karen Alarid and Emily Sanchez with the City of Moriarty. Steve Anaya asked if the agenda was approved by the City Attorney before going into the closed session which the City Clerk, Deborah Liu, responded affirmatively. Jeremy Trujillo Seconded. Steve Anaya voted YES, Bobby Ortiz voted YES, Kim Garcia voted YES and Jeremy Trujillo voted YES. Motion Carried.
OPEN SESSION	Bobby Ortiz motioned to go back into open session. Kim Garcia Seconded. Jeremy Trujillo, Steve Anaya, Bobby Ortiz and Kim Garcia voted AYE. Motion Carried. Only the compensation of a proposed 90-day contractual agreement between Karen Alarid and Emily Sanchez with the City of Moriarty was discussed. No Action was Taken.
RECORD ACTION	Bobby Ortiz moved for the City to enter into a provisional three-week contractual agreement with Karen Alarid (\$100.00/hour) and Emily Sanchez (\$70.00 /hour) to assist the City Clerk's Office into gathering fiscal findings and go back to present such findings and a corrective action plan to the City Council on May 28, 2025, during a Special Meeting. Kim Garcia Seconded.
