	The Moriarty City Council met at Regular Meeting, with the following members present: Mayor Steve Anaya, Robin Spalding, Kenny Snow, Kim Garcia. Jeremy Trujillo all present
CALL TO ORDER	Mayor Steve Anaya called the meeting to order at 6:30pm.
AGENDA	Councilor Garcia made a motion to approve the agenda with the request to remove item # 3 per Bob Hudson, second by Councilor Trujillo, all present voted yes, motion carried.
Governing Body Update	Councilor Snow had a request for public works on getting the graffiti cleaned up at the park he also asked that we review the Planning and Zoning commissions authority.
Public Comment	Ashely Williams shared her resignation letter.
Consent Agenda	Councilor Garcia made a motion to approve the consent agenda with some corrections to the draft for final copy, second by Councilor Snow, all present voted yes, motion carried
Wastewater	Mayor announced that the city was awarded \$ 10 million with 80% of that being grant money and 20% loan for the wastewater treatment site.
Airport	This item was removed
Lee Scapes	Councilor Trujillo made a motion to approve the additional expense of approx. \$ 6000 for the cemetery renovations, for the wall cap, second by councilor Garcia, councilor Snow yes, Councilor Spalding NO, motion carried
Pinto Bean	Councilor Garcia made motion to approve the lodger's recommendation for \$ 10,000 to the Pinto Bean fiesta budget, second by councilor Snow, all present voted yes, motion carried
Police Chief Urbina	Chief Urbina is asking for a wage increase for his administrative assistance Kelly Tapia, from \$ 24.52 to \$ 27.63, councilor Garcia wanted to confirmation of what Jeanette Hendricks made since she feels that Jeanette and Kelly have the same job title she feels given her amount of time with the city and her job duties she will make a motion to approve a pay raise for Kelly Tapia in the amount of \$ 30.57, second by Councilor Trujillo , councilor Snow voted yes, with making a comment that he feels the city needs some processes in place moving forward and Councilor Spalding voted yes, motion carried. Councilor Spalding stated that the city needs to get a process for employee raises which should include annual reviews and a process moving forward. Chief Urbina gave a department update
Mayor and Jeff- Salary increases	Mayor and Jeff presented the council with three salary increases: They are asking for approval of lead maintenance positions for Andy Elias and Joseph Sedillo and Dave Hammond as wastewater supervisors. Councilor Snow is asking for job descriptions not job duties and would like to know if this is a promotion and what is the policy for these promotions. He feels that there needs to be a complete job description on these positions and some research on proper procedure for these promotion positions. Councilor Snow made a motion to table items 7 A.B.C. ,second by councilor Garcia, all present voted yes, motion carried.
Public Works- Jeff Tapia	Councilor Garcia made motion to approve the purchase of pump in the amount of \$ 6996.00 from line item 501-6003-56030, second by councilor Snow, all present voted yes, motion carried. Jeff gave a department update
Library Natalie Bott	Natalie asked for approval to hire Donna Carpio for the part time position at \$ 15.00 per hour not to exceed 19 ½ hours per week, she did inform the council that interviews were completed. Councilor Snow made a motion to approve to hire Donna Carpio, second by councilor Spalding, all present voted yes, motion carried.
